**PUBLISHER CONTRACT**

**MEMORANDUM OF AGREEMENT**

Made and entered into by and between

AND

**SOUTH AFRICAN RECORDING RIGHTS ASSOCIATION LIMITED**

A company with limited liability duly incorporated in accordance with the laws of the Republic of South Africa

- SARRAL is hereby authorised to license and collect all mechanical royalties of whatever nature and howsoever arising as may accrue or become payable to the owner there from during the term of this agreement in respect of all recordings and mechanical reproduction of all musical compositions composed and/or controlled by the PUBLISHER (hereinafter referred to as "SAID WORKS") for the territory of the World (hereinafter referred to as "SAID TERRITORY")
- SARRAL is not authorised to grant permission for the use of any SAID WORKS in motion picture soundtracks, except Television Films made by a licensed broadcaster without first obtaining written or cabled permission from the PUBLISHER.
- In the event of royalties being received by SARRAL, SARRAL agrees to forward the Publisher statements of royalties collected and credited to his account, accompanied by monies shown to be due, within sixty days of expiration of each period being 31 May and 30 November of each year.
- In consideration therefore, SARRAL shall be entitled to retain a commission of 9% of the gross total of royalties collected.

- The PUBLISHER agrees to notify SARRAL of all compositions coming within his control for the Said Territory.
- The Publisher is entitled to sub-publish all or any of the Said Works in the Said Territory, during the term of this agreement provided SARRAL continues to collect at the source the Composer's and Author's share of mechanical royalties as determined by any such publishing agreement that may be entered into by the PUBLISHER.
- Where SARRAL deems it necessary to protect, enforce, enhance and/or collect mechanical royalties due to the PUBLISHER, the PUBLISHER shall be deemed to have ceded, transferred and assigned his copyright to SARRAL for the sole purpose of instituting action for the necessary legal relief in SARRAL's or it's nominee's name. In such event SARRAL shall bear all legal costs and disbursements in regard to the action brought. To achieve this purpose, the owner hereby cedes transfers and assigns unto and in favour of SARRAL all his right, title and interest in and to all his rights to and in respect of the said works. After the action referred to has been entirely disposed of, SARRAL shall cede, transfer and assign all and any rights it might have received in terms of this clause to the PUBLISHER.
- The PUBLISHER shall be entitled during the currency of this agreement to apply for membership of SARRAL subject to the Memorandum and Articles of Association of SARRAL.
- This agreement shall remain in force for THREE (3) years from the date hereof and shall thereafter be renewed from year to year by tacit agreement unless terminated by either party giving to the other notice in writing by registered pre-paid post at least Two (2) months prior to the expiration of the periods referred to earlier in this clause.
